The mechanical damages of the discuses (scratches, dents and so on) caused by landing on the throwing sector or other discuses remaining on the throwing field are recognized as a normal wear of the product and are excluded from the warranty.




I. Use

The competition plastic discuses are designed for discus throw competitions and training programs.

Discus rim made of special alloy resistant to corrosion, plastic sideplates. The discuses are made according to the IAAF specifications:
